LOC Number 40329 is hereby amended as follows:

Attachment A, Cost Information Form – LOC Number 40329 is being replaced with the attached Revised Cost Information Form – LOC Number 40329 to reflect a change in scope for the following item:

1. On page 6 of the memorandum, the table in Attachment A, *Cost Information Form* has been updated to accurately represent the licensing needs of the University.

The following questions were submitted to ITS and are being presented as they were submitted, except to remove any reference to a specific vendor. This information should assist you in formulating your response.

Question 1: Part number CTS-PHD1080P4XS, with serial # FTT163500SV is installed in part number, CTS-SX20-PHD4X-K9 with serial # FCZ1622F059. Serial # FCZ1622F059 is on the list but serial # FTT163500SV is not. Both items have a separate price to cover, do both serial numbers need to be covered?

Response: Please refer to Clarification Number 1 of the Memorandum.

Question 2: Per Cisco, serial #A1AR46C00166 is already covered through 28-Feb-2015. Should this be quoted, starting in Year Two and pro-rated? And then one full year coverage in Year 3?

Response: Yes, coverage should be proposed for the prorated portion of time from expiration through September 30 of the applicable year. Yes, full year coverage should be quoted for the applicable years for which 12 months of coverage are available.

Question 3: The customer location is not authorized for C4P SMARTnet Onsite Premium 24x7x4.Do they want 8x5xNBD or 24x7x4 (not onsite)?

Response: The University would prefer 24x7x4 (not onsite) if Onsite Premium is not available.

Question 4: Would USM like to see pricing and discounts associated with purchasing three years support up front?

Response: The University would evaluate alternate pricing based upon 3-year prepayment; the pricing must also be provided on a year to year basis requested.

Question 5: Section 6, 6.2 – Vendor must have a Cisco Certified Internetwork Expert (CCIE) on staff._*Question:* Will you accept other Cisco certifications to take the place of the CCIE certification? If so, is there a specific certification you would take in the place of the CCIE?

Response: No, alternate certifications will not be considered.

Question 6: We noticed there is no begin or end dates specified on the LOC. There is no consistency in the end dates on the equipment. Should we quote coverage based on a full year or do we need to co-term for specific dates.

If we co -term for specific dates coverage could be less than one year, more than one year, etc...

Example:

Several of the 6504's are due to expire on January 10, 2014. If we set a co-term date of June 30th, 2014 then the coverage will be for less than one year.

Please advise on how to quote end dates.

Response: USM requests that all coverage co-terminate on September 30. Coverage should be proposed for the prorated portion of time from expiration of the current maintenance agreement through September 30 of the applicable year. Full year coverage should be quoted for the applicable years for which 12 months of coverage are available.

Specifically regarding your example, the maintenance should be quoted from the expiration date of January 10, 2014 through September 30, 2014. Full year (12 months) coverage should be quoted for subsequent years.
